**AGREEMENT:** This agreement is a firm and binding contract between Jones Creative ("Jones Creative" refers to Jones Creative, its lessees, contractors, subcontractors, agents or servants.), and the undersigned (hereafter referred to as "Client"), as evidenced by their signatures below.

1. **SERVICES:** Jones Creative agrees to videotape, edit (no editing in the "No Edit" package) and deliver as a packaged DVD-R and Blu-ray Disc, Client's event as noted on page 1. Parents receive a DVD.
2. **PAYMENT:** A non-refundable deposit in the amount of 50% of the total amount of the services requested must be paid in order to reserve the date of this event for Client with Jones Creative. This deposit also acts as consideration for this contract. The remaining balance of 50% is due two weeks prior to the date of the event. If Client does not pay all balances due at least two weeks prior to the event, Client's deposit will be forfeited and Jones Creative will be under no further obligation to Client.
3. **EVENT CHANGE/ CANCELATION:** This agreement is for the exact date and services noted on page one. If payment has been paid in full, the date of the event is changed, and Jones Creative is still available, Jones Creative will videotape Client's event on the new date for a \$500 date change fee. If Jones Creative is not available or if the event is canceled, Jones Creative will refund Client's money, less the non-refundable 50% deposit.
4. **COMPLETION TIME:** The completed video will be delivered to Client within approximately 16 weeks after the event. Any extension of time beyond this will not void this contract. Jones Creative will contact Client if circumstances extend this time frame, and will give Client a new approximate date.
5. **VIDEO/AUDIO LIMITATIONS:** Client assumes responsibility for obtaining permission for access to any needed camera positions and audio recording device placement. Jones Creative is not responsible for loss of video or audio quality due to restrictions at event locations. Additionally, Jones Creative does not guarantee any particular effect, interview or special request.
6. **PERMITS/PARKING:** Client assumes all responsibility for obtaining any necessary permission, clearance permits, etc., which may be required for Jones Creative to perform the duties specified in this contract. Client is solely responsible for any parking, admission fees, passes, tickets, etc. necessary for Jones Creative to gain access to all locations to video this event.
7. **MEALS:** Client will provide Jones Creative and its crew a meal if a meal is served during the event.
8. **EXCLUSIVITY:** Jones Creative is the exclusive videographer retained by Client to videotape this event. Client is responsible to ensure that Jones Creative is not hampered in its abilities to perform said services due to other vendors' time, space and other needs.
9. **COPYRIGHTS:** All rights to video produced by Jones Creative, including reproduction of said video and use of all images for marketing and advertising purposes, are reserved by Jones Creative.
10. **RELEASES:** Client is acting as agent for all persons that will appear in this video and grants Jones Creative all rights for display, airing and advertising use of all video produced under this agreement.
11. **PRODUCTION MATERIAL:** All personal property provided by Client to Jones Creative for inclusion in the video is received by Jones Creative at the complete and total risk of Client. All materials will be shipped back to Client with the completed video. Client warrants that he/she has the legal copyrights to anything provided to Jones Creative for inclusion in Client's video, as well as legal rights to anything that Jones Creative is asked to videotape for this event. Client agrees to indemnify and hold Jones Creative harmless for any loss, damage or liability for infringement of any rights arising from the use or sale of videos Client hires Jones Creative to produce, edit or duplicate.
12. **LIABILITY LIMITS:** Liability is limited to a refund of all monies paid by Client to Jones Creative. In the unlikely event that a problem arises, whether due to lateness, accident, human error, loss of materials, acts of God, equipment failure or other issues, and Jones Creative is unable to provide the completed video, all payments will be refunded to Client. Jones Creative will provide a professional videographer to shoot the event if Jones Creative cannot attend for any reason.
